

Project TOPS began as a collaborative partnership with the Florida Developmental Disabilities Council, Inc. (FDDC), Miami-Dade County Public Schools (MDCPS) Office of School Operations and Adult Education and Robert Morgan Educational Center & Technical College (RMEC & TC). TOPS is approved and currently funded as a Florida Postsecondary Comprehensive Transition Program by the Florida Center for Students with Unique Abilities (FCSUA) at the University of Central Florida (UCF). The mission of Project TOPS is to serve the unique abilities of students with documented intellectual disability or intellectual disability with other co-existing disabilities enrolled in a fully inclusive postsecondary Career Technical Education (CTE) programs. Students are enrolled in a fully inclusive career technical education (CTE) course. Referral to the program can be initiated by a student (who is willing to self-disclose a disability and requests additional supports), a parent, counselor, teacher, Transition Specialist and/or Vocational Rehabilitation Consultant. The Project TOPS Team provides supports to students through in class instruction and after school sessions. Students registered in ONLY the CTE programs listed below may be eligible for services, based on available class enrollment: Automotive Service Technology, Baking & Pastry Arts, Professional Culinary Arts & Hospitality (after successfully completing Baking & Pastry Arts), Commercial Art Technology, Nails Specialty, Plumbing and Welding Technology.
